



**All rebates are capped at 70% of actual cost or the approved amount, whichever is less.**

The Heat Pump Water Heater (HPWH) rebate is available to new and existing, single-family homes and manufactured homes. In existing homes, the Unitary Heat Pump Water Heater must replace an electric storage water heater on a one-to-one basis and be within CREA's service area.

The HPWH must be listed on the Northern Climate Qualified Heat Pump Water Heater list, found at: <https://www.bpa.gov/EE/Sectors/Residential/Pages/Heat-Pump-Water-Heaters.aspx>. The HPWH must be installed by a contractor who has received manufacturer's training (visit <http://smartwaterheat.org> for a list of trained contractors), or a homeowner that has completed on-line training, found at: <http://www.bpa.gov/Energy/N/residential/HPWH/Index.cfm>.
